Welcome! Thank you for subscribing to FrontLine Employee. FrontLine Employee is the most innovative workplace newsletter program ever. This license explains the use of the newsletter.

FrontLine Employee is a professional authored, editable, reproducible, easy, and inexpensive workplace wellness newsletter for human resources, EAPs, wellness programs, or any employer of any size. FrontLine Employee content may be edited or used as content in your existing publication or template, or other internal publication. Content is for your employees only and family members, or for the employees of your customers if you are an employee assistance program, employee leasing company, employer association.

1. You are scheduled to receive an electronic copy of the newsletter in the format you request. Your electronic copy will arrive before the first day of the month of issue, usually no later than the 26th of the preceding the month. Phone us if you do not receive your emailed copy by the 26th so it can be resent.

2. This license gives you permission to edit, reproduce, and distribute FrontLine Employee content to employees of, or served directly by your organization.

3. You may place content of the newsletter on an internal website without restriction. However, if you post FrontLine Employee to a Web site accessible via the Internet, you must use a password or any other means of your choosing to prevent use by unauthorized persons surfing the Web. Please refer any company to us you believe would benefit from FrontLine Employee.
